

Skilled Nursing (RN, LPN)

- Skilled assessment and vital sign check

- Safety and mobility assessment and education

- Education on bed mobility, safe transfers and safety on stairs
- How to safely use an assistive device such as a cane or walker

If your healthcare provider orders home care services and you meet the Medicare requirements, Medicare pays 100%. It may vary for those on a supplemental plan. We recommend you contact your insurance provider for more information.

How long will Medicare allow me to receive services in my home?

Services can continue as long as you meet Medicare guidelines.

I have a case worker at the county and receive a waiver, can you help me with medications and other care?
