

Healing through Music, Care, and Joy

Affectionately known by everyone as “Mr. Tom,” this spirited gentleman brought more than just medical records when he first walked through the doors of the Senior CommUnity Care of Jefferson County PACE Center (Kentucky) — he brought music, joy, and a presence that’s hard to forget.

Mr. Tom lives with his daughter. Before he joined PACE, Mr. Tom’s daughter managed his many required appointments, medications, and follow-ups related to his complex health condition. His medical journey was anything but easy. Because he was fragile in health and facing several obstacles, his daughter often bore the weight of caregiving alone.

But everything started to shift the day Mr. Tom became a PACE participant.


From the very beginning, Mr. Tom lit up the PACE Center with his energy. A natural entertainer, he wowed the crowd daily with his music, quickly becoming a favorite among both participants and staff. He now attends the PACE Center five days a week, where all of his appointments, diagnostic tests, and transportation needs are carefully coordinated — relieving his daughter of the burden and giving her the chance to enjoy her own life again.

“I’ve got my problems,” Mr. Tom admits, “but since I’ve been with PACE, I don’t even think about them. I’m just happy.”

He shared that a recent diagnostic test showed no ongoing concerns — something he celebrates with cautious optimism. “Of course, not everything is because of PACE,” he says, “but getting good, consistent care sure helps.”

Mr. Tom is especially fond of the activities assistant who helps keep his days filled with purpose and fun. Whether it’s singing, socializing, or just soaking in the energy of the center, he’s found a second home at PACE — one that gives him both joy and peace of mind.

For Mr. Tom, healing has come not only through medicine, but through music, laughter, and the knowledge that he — and his daughter — are no longer in this alone.







VOANS and Volunteers of America of Florida Celebrate Grand Reopening of 2 Affordable Senior Housing Communities

In partnership with Volunteers of America of Florida, VOANS celebrated the reopening of Clear Bay Terrace and Creekside Manor I & II in Clearwater, Florida, in February 2025. The celebration was held at the newly renovated Clear Bay Terrace - a 40-year old, 101-unit affordable housing property for seniors located in close proximity to Creekside Manor I & II, a 91-unit housing community for seniors that was also recently renovated.

The separate rehabilitations feature a number of enhancements designed to offer a contemporary and comfortable living environment for residents such as in-unit features inclusive of new flooring, energy-efficient appliances, water heaters,

light fixtures, bathroom upgrades, and enhanced ADA unit upgrades to ensure accessibility. Notable common area improvements include new flooring, new light fixtures, a new HVAC system and WiFi accessibility.

"We are thrilled to welcome seniors back to these beautifully renovated homes," said Dee Dee Beaty, VOANS senior vice president of housing. "This rehabilitation project represents our ongoing commitment to preserving affordable housing options for older adults in Clearwater, providing them with safe, accessible, and comfortable living spaces that will enhance the quality of their lives."

PACE Maryland & Northern Kentucky Open

VOANS continues to expand its reach and impact through PACE — officially opening Northern Kentucky PACE and Maryland PACE.

In partnership with VOANS PACE Holding Company and St. Elizabeth Healthcare, Senior CommUnity Care of Northern Kentucky hosted a grand opening and ribbon cutting ceremony in July 2024. The center serves eligible participants residing in eight counties across northern Kentucky.

“We are excited to bring the Senior CommUnity Care of Northern Kentucky PACE program to this region,” said Robert McFalls, executive director of Senior CommUnity Care of Northern Kentucky. “Our goal is to provide high-quality, person-centered care that addresses the physical, emotional and social needs of older adults, while also providing much-needed support to their families.”

VOANS and CCI Health Services celebrated the grand opening of the first Program of All-Inclusive Care for the Elderly (PACE) in Prince George’s County, Maryland. Located in Hyattsville, Senior CommUnity Care of Maryland PACE is open to area residents aged 55 and older who can live safely at home.

With both nonprofits having similar missions of supporting access to care and bright futures for all communities, the collaboration between VOANS and CCI Health Services makes sense. PACE is a true community-centered model that allows seniors to remain in the homes they love while receiving the care they need to stay healthy, active, and connected.

“For many seniors, the greatest wish is to remain in the comfort of their own homes as



they age,” said Kelly Fields, executive director of Senior CommUnity Care of Maryland.

“Our team of healthcare professionals works together to address every aspect of a senior’s well-being - physical, emotional, and social. We’re not just treating medical conditions; we’re enhancing quality of life and providing peace of mind for families.”




The PACE program offers a wide range of services, including primary and specialty medical care, prescriptions, rehabilitation, transportation, day center, social activities, meal assistance and in-home care services. Participants in the program receive an individualized care plan developed by a team of healthcare professionals, including doctors, nurses, social workers, therapists and nutritionists, who work collaboratively to ensure the best possible care for each participant.

States pay PACE programs on average 12 percent less than the cost of caring for a comparable population through other Medicaid services, including nursing homes and home and community-based waiver programs.

In Medicare, payments to PACE organizations are equivalent to the predicted costs for a comparable population to receive services through the fee-for-service program.



Faith, Family, and Finding Independence Again

At Senior CommUnity Care of Kentucky PACE, one of the participants — affectionately known as Ms. Hattie — is a well-respected Christian and senior in the community, who now calls Friendship House her home. Her presence and deep faith have made her a beloved figure in the community. But her journey to becoming a PACE participant is one marked by struggle, resilience, and a rediscovery of independence.

Originally from a small town, Ms. Hattie faced a difficult time after being discharged from the hospital. Her health declined, and she found herself unable to manage day-to-day life. That's when she moved to Friendship House — and as she puts it, "From there, it was history."

At first, Ms. Hattie rarely left her apartment, only venturing out for religious events or to check the mail. She was physically limited, often in pain, and deeply saddened that she could no longer attend church — an essential part of her spiritual and social life. Her devoted sister-in-law, Bonita, did nearly everything for her, while also caring for her own brother and her husband (Ms. Hattie's brother). The turning point was when Ms. Hattie enrolled in the PACE program.

"PACE is the best thing that has ever happened to me," she says with a smile. "Call it lazy if you want to — but I like not even having to leave the building to get everything I need."

Today, Ms. Hattie is thriving. She comes to the PACE center not just for medical care or to pick up supplies, but to reconnect with old friends, make new ones, and enjoy lunch in

good company. The socialization has lifted her spirits, and the care she receives has transformed her physical capabilities.

On the day of her interview, Ms. Hattie was glowing — it was her birthday. Her family had taken her out to Golden Corral, and she was especially eager to share the news with her physical and occupational therapists: "I got into my sister-in-law's car with very little pain, and I was so excited!" she beamed. "Next, I'll be going back to church. Before, my pain was so bad I couldn't ride in a vehicle. Now, I'm almost ready."

Thanks to PACE, Ms. Hattie says she feels like she has her independence back. Just as importantly, she's grateful that Bonita can now focus on her own health and caring for her husband. "I feel like myself again," she says. "And that's a blessing."

The Preserve Celebrates 5 Years of Making an Impact

2,142. That's how many older adults The Preserve, a senior living community in Fort Myers, has served since we opened our doors in 2020. But each resident we've served is more than a number - they're family.

This year, we celebrate a significant milestone — the fifth anniversary of The Preserve. This isn't just a mark on the calendar, but a celebration of the friendships, memories, and achievements that make this community special. We've overcome so many obstacles from our first day open, from opening just before the eruption of COVID-19 to sheltering with residents in our community during multiple major hurricanes.

We opened our doors in the spring of 2020, and since then, we've been serving older adults who need assisted living, skilled nursing, memory support, or rehabilitation services. However, our pathway to serving older adults started 10 years ago during a time of critical need.

In 2015, former Governor Rick Scott released a Certificate of Need for 75 skilled nursing rooms. VOANS responded to this need and was awarded the responsibility because of its reputation and history of providing high-quality care. The result was The Preserve, a three-story, 118,000-square-foot community offering assisted living, memory support, and 75 skilled nursing suites for long-term care, skilled nursing memory support, and skilled rehabilitation. These options provide residents with the unique opportunity to



stay at The Preserve as their medical needs change.

Five years later, we're proud to have served over 2,000 seniors in all capacities, from outpatient rehabilitation to skilled nursing. We couldn't do it without our team, many of whom have been with us since our doors first opened. These exceptional people care for our residents and contribute to the quality of life in Southwest Florida. Even though they aren't related, our team treats each resident with the care, compassion, and attention they would give to a family member.

We wouldn't be the community we are today without our residents. When speaking with our residents about what they love so much about The Preserve, one of the most common responses is "the people."

Maureen Arend, 86, didn’t plan on moving to The Preserve. She had a home in Southwest Florida and family nearby. In 2022, she was recommended to check out The Preserve by her tax professional. She got a tour, fell in love with the decor, and months later was moving into our community.

“I’ve met some wonderful people, and there’s no place else I’d rather be,” says Arend.

Beverly Larsen, 91, moved to our community in 2021, but her late husband, Loren, was one of the first residents at The Preserve in February of 2020. While Beverly still lived in her home in the Gateway area, she would frequently travel to The Preserve.

“After almost two years, I decided it was time to sell the house because I was coming here so often,” says Larsen. “I moved into The Preserve in October of 2021, and this is where I’ll stay.”

Since moving to our community almost four years ago, Larsen has made many friends and enjoys participating in community activities.

Another long-time resident, Barbara Weinberg, appreciates The Preserve’s team for their empathy, care, and dedication toward residents.

“It’s the warmth of the people. All the people who work here are very special. I think it’s a mantra of this place. They care,” said Weinberg. “And that’s what makes The Preserve great.”

To our residents, you’re the heart of our community. Your stories, wisdom, and laughter make this community a home. To our associates, your compassion and hard work every day ensure that every resident feels cared for and valued. For the past five years, we’ve shared countless unforgettable moments, celebrations, activities, and just enjoyed being together. As we reflect on these years, let’s also look ahead to the future and the memories we’ll make over the next five years.



Seniors Find a New Home at Paloma Garden in Colorado

Colorado Springs is now home to Paloma Garden, a new 125-unit affordable housing community for seniors age 62 and older. VOANS hosted the official ribbon cutting ceremony in May 2025 where City of Colorado Springs and State of Colorado officials were in attendance, as well as financial partners including First Bank, Enterprise, Colorado Housing & Finance Authority, and El Paso County Housing Authority.

The redevelopment, which formerly housed the Laurel Manor Care Center, was funded by an allocation of tax credits from the Colorado Housing and Finance Authority (CHFA) and equity from Enterprise Partners, First Bank, the Division of Housing (DOH),

and El Paso County provided loans to support the development. Paloma Garden was planned in response to the rising demand for affordable housing in Colorado Springs, especially among marginalized communities like senior citizens and the disabled.

The development was a combination of renovation and new build. The renovation upgrades included new windows, energy efficient plumbing, light fixtures, and updated common areas. The new build features in-unit washers and dryers, walk-in showers, and beautiful new kitchens and bathrooms. The development offers one- and two-bedroom units serving the 30-60% Area Median Income (AMI) range which is \$585 - \$1,404.

The Homestead at Rochester Donates Warmth to Those Experiencing Homelessness in Rochester, MN

The Homestead at Rochester, a VOANS senior living community in Minnesota, donated hundreds of outdoor winter clothing items to the local Rochester Salvation Army in October 2024. More than 200 items were specifically gathered for distribution to individuals within the Rochester community who were experiencing homelessness.

“The inspiration for giving back and supporting the unsheltered was brought to me by two of our residents Bob Keith and Sue Johnson,” said Director of Life Enrichment, Alexandra Schepp. “What we thought would be a small coat drive, quickly grew into hundreds of donated items by our residents and staff.”



Volunteering has been shown to offer significant health benefits, particularly for older adults. Studies indicate that volunteering can boost mental and emotional well-being by reducing stress, fostering social connections, and creating a sense of purpose.

Healthcare Communities Recognized Among Best Nursing Homes by U.S. News & World Report

Four of VOANS’ skilled nursing care centers across the country were named as Best Nursing Homes by *U.S. News & World Report*. Horizon Care Center in Eckert, Colorado, The Preserve in Fort Myers, Florida, Anoka Rehabilitation and Living Center in Anoka, Minnesota, and Rochester Rehabilitation and Living Center in Rochester, Minnesota, all received a high performing rating in short-term rehabilitation — a distinction that places them in the top percentage of nursing facilities nationwide. The Preserve also received a high performing rating in long-term care.




